Sub: - Regarding social forestry & IBS horticulture scheme

You are aware that the rainy season is coming to the door & therefore, you are requested to complete the preparatory activities i.e estimate preparation, vetting, administrative approval, Brikhya Patta, pit digging & pit filling with organic manure & insecticide etc within 15 june, 2017.

You are also requested to provide Brikhya Patta to vulnerable family which belongs to SC/ST/BPL/Housing scheme etc. & specially to physically handicapped & other weaker section, old age, widow job card holders should be given priority. No plan can be executed without hand over module (Brikhya Patta).

You are also informed that thirty (30) nos fruit plants should be planted in the specific area (having 750 sq metre) of beneficiaries under IBS horticulture scheme. The plant to plant & row to row distance should be as per specification. The Nirman Sahyak of all Gram Panchyat are requested to visit the field before estimate vetting. If there are found sufficient land the NS will vet the IBS horticulture scheme and the Gram Panchyat will send it to the BDO for administrative approval. BDOs are requested to form a monitoring team who will visit schematic area atleast 50 % of the vetted scheme by GP before giving administrative approval from block end and the team will submit the report to the BDOs with specific comment wethere the IBS horticulture scheme should be executed or not.

The payment to the beneficiaries (IBS horticulture scheme) shall be based on activities carried out as per schedule and survival of plants (90% above full wage, below 90% half wage and below 75% no wage) on a monthly basis.

All PIAs are requested to follow this guidelines strictly.
