
Madam/Sir,

In terms of order No.1974 dated 18/08/2017 issued by this Department, vetting power of Nirman Sahayak, Sub-Assistant Engineers, Executive Engineers and Superintendant Engineers at different levels of the Panchayat system have been enhanced with immediate effect. In terms of Order No.97 dated 03/11/2013 issued from this office any enhancement in the vetting power of the Nirman Sahayak is to be construed as enhancement in the vetting power of the Technical Assistant at the block/district level contractually engaged for implementation of Mahatma Gandhi NREGA. Accordingly, the latest order of the department in respect of the Nirman Sahayak will apply to the Technical Assistants in the MGNREGA set up mutatis mutandis.

It is also specified that vetting powers of the Sub-Assistant Engineers, Assistant Engineers and Executive Engineers in the MGNREGA set up at the district or any other level will also follow the pattern of vetting power of corresponding engineering officials, as indicated in the departmental order of 18th August 2017.

It is reiterated that for any future changes in the vetting power of the engineering staff in the PRI set up, there will be corresponding changes of vetting power of respective officials in the Mahatma Gandhi NREGA as well. This may immediately be communicated to all the field functionaries.

In terms of Notification No. 6853-RD (JRY)/13E-9/2010 dated 1.10.2012, vetting power of the Nirman Sahayaks has been raised to

- a). Rs.3.00 lakh for earth work and
- b). Rs.1.50 lakh for other public work.

Since the vetting power of the Technical Assistants contractually appointed under Mahatma Gandhi NREGA has been kept at par with that of the Nirman Sahayaks, it is hereby ordered that the vetting powers of the Technical Assistants under MGNREGA too is revised in identical manner.

It is further ordered that in future no separate order would be required for enhancement of the vetting power of Technical Assistants under MGNREGA subsequent to enhancement of the vetting power of the Nirman Sahayaks and the same shall be automatically enhanced.


